### 4. MINUTES

The Minutes of the Parish Council meeting held on the 10<sup>th</sup> June 2015, were considered; confirmed and signed by the Chairman as a correct record.

# 5. RECEIVE REPORT FROM WARD COUNCILLORS

The Ward Councillors spoke of the new City of York newsletter called 'The Voice', which will now be spilt into 4 publications – North, South, East and West. A quarterly publication will be delivered, by hand, to every household. Each publication will include a consultation about a particular issue, with the first issue looking at the City Plan.

It has recently been agreed that the Rawcliffe Country Park can be used for smaller, charitable events only.

The Ward Councillors are currently pushing for legal action to be taken again illegal fly signage, including A boards and movable trailers.

The Ward Councillors advised that pprox 2 thirds of the 20mph signs within York have now been installed with City of York Council currently investigating as to whether they should leave the signs up but not to install anymore, with many people seeing the signs as 'street litter'.

Green bins - It has been advised that 2 additional collections will now be made, one at the start of the season and one at the end.

- 10.4 Any other urgent request submitted to the meeting –
- a. To discuss and agree the purchase of a printer for the Clerk After discussion, the Parish Council agreed that the Clerk could be authorised upto a maximum spend of £150.00 for the purchase of a new printer.
- b. Donation request by Friends of Canon Lee School, following revised information on where the defibrillator could be housed Following a full discussion, by majority vote it was agreed that, on this occasion, the Parish Council would be unable to agree to this donation request. This is due to the input into the local community being limited and the fact that the unit is being housed on school grounds. The Parish Council do not feel that that it is something that public funds should be used on.
- c. To discuss and agree costs relating to storage unit, as per discussions via email Clerk advised that due to the large number of documents and files that need to be retained she is running out of available space at home and enquired as to whether the Parish Council would be willing to take on an external storage unit to house all documents and that the costs associated with this would be shared between the 3 Parish Councils she looks after. It was resolved that the Parish Council would be happy to do so. Clerk to arrange a unit with Stadium Self-Storage as they provided the most competitive quotation and offered a discount for Parish Councils.
- d. Members of the finance committee to carry out an internal spot check on quarter 1 of the 2015/16 accounts, followed by the signing of the Internal Financial Control form Councillors Smailes and Murray were appointed as members of the finance committee for the purposes of carrying out the quarterly internal spot check of the 2015/16 accounts.

The spot check of quarter 1 of the 2015/16 accounts was carried out by Councillors Smailes and Murray at the end of the meeting and the Internal Financial Control form duly signed.

e. The signing of the Barclays Bank mandate form, adding on new signatories – The mandate form was signed by Councillors Paylor and Ellis and personal detail forms passed to Councillors Smailes and Murray for completion so that they can be added onto the account.

## 11. MEETING REPORTS/REPRESENTATIVES

Councillor Naylor advised that an allotment committee meeting has recently taken place where it was discussed that some additional fencing will need to be installed as some residents have experienced issues with deer roaming into the area. There are currently some allotments available for rent.

Councillors Elis and Rawlings advised that they both attended the recent police event at the Spurriergate Centre in York. They advised that key issues raised including the nighttime economy/use of York for social events and the parking issue on Kettlestring Lane.

# 12. EXCEPTIONAL ITEMS

Councillor Smailes advised that the notice board outside the scout hut, on which it had previously been agreed that the scouts could use the board to publicise the water paper collections is in a poor condition and the backing within the board is disintegrating, making it hard to display notices. Councillor Paylor advised he would look into this.

Councillor Naylor advised that the grass on the Backies needs cutting. Clerk to chase up CYC as to when the Backies clean up will take place.

Councillor Naylor raised issues with the visibility for cycle users when using the Tamworth Road/Lancaster Way roundabout. Councillor Naylor believed that the CYC were asked to look into this junction approx. 3-4 years ago but that nothing has changed. Clerk to investigate.
