Erection of new building for vehicle rental office with wash bay and associated vehicle storage, parking areas and landscaping following demolition of existing buildings on site.
Decision – The parish council do not object to this planning application but do wish to make the following comment - If the application were to be approved the parish council would like to see the application to include the maintenance of the cycle path route that runs behind the property.

Display of 1no. internally illuminated fascia sign, 1no. band sign, 1no. portable car return trolley sign, 1no. directional monument sign and 1no. internally illuminated totem sign.

20/01739/FUL 3 The Close, Rawcliffe, York
First floor rear extension to bungalow with dormer and hip to gable, erect detached garage and shed after demolition of existing garage.
Decision – The parish council do not object to this planning application but do wish to make the following comment - The parish council have concerns regarding possible fire safety issues relating to this application.

Single storey side and rear extension and 1no. new ground floor window opening to side elevation following demolition of 2 storey rear projection.

Two storey side and single storey rear extension - resubmission.

20/01832/TPO 12 Malton Way, York
Reduce crown of Sycamore in height by 25% - protected by Tree Preservation Order no.CYC299.

Display of 2no. internally illuminated fascia signs (Retrospective).

7. MATTERS ARISING

- (a) An update on the proposal for a Citizens Advice York Rawcliffe & Clifton Without outreach programme was discussed. It was agreed for the council to try to speak to the Rawcliffe Rec again to see if the building could be used to hold face to face meetings. Again, it was agreed that CW PC are still happy to proceed with funding a scheme one day per month, split with Rawcliffe Parish Council.
- (b) The recently received annual play inspection report from Rospa play safety was discussed and the following actions were agreed:-
- (i) The urgent repairs to the basket swing and slats on both the infant and junior multi play units to be fixed immediately. Clerk to arrange with MacVenture.
 - (ii) A sub committee working group of Councillor Sam Waudby and Andy Dearden was formed to look at all the other issues raised in the report.
- (c) Ward Councillor Sam Waudby provided an update on the pedestrian crossing on Water Lane. She advised that the Ward Councillors have asked CYC to carry out a feasibility study. However, in the first instance CYC have carried out an assessment value which looks at things such as capacity and number of journeys and from that information they will assess whether a feasibility study is required and how much it will cost.
